#### **VOTER INFORMATION**

General election voter registration deadline: Oct. 5, 2020

Early voting and mail-in voting begins: Oct. 6, 2020

Deadline to request absentee ballot: Oct. 31, 2020 at 12pm

Early voting and mail-in voting ends: Nov. 2, 2020

General election: Nov. 3, 2020 polls are open from 6:30 a.m. until 7:30 p.m.

How "Bicyclist's Guide to Voting" is compiled: The Bike Miami Valley Regional Advocacy Committee compiles the voter guide to provide a forum for candidates to discuss issues of walking, bicycling and street ortrail use that are important to our members. Bicycling is a legal form of transportation in Ohio and has the same rules and rights to the roads as other vehicles. Letters with three questions were mailed to candidates in races within the Miami Valley area (counties that are represented in Bike Miami Valley's regional membership base). Candidate responses have been printed to fit formatting. Candidates who did not respond or did not meet the stated deadline are listed at the end. Asterisks (\*) notes the incumbent candidates, underneath how many candidates a voter can select at the polls. Bike Miami Valley does not endorse or support views of any candidate or political party. Nor does Bike Miami Valley assume responsibility for the content of any candidate's reply.

## Question 1: Distracted driving and Ohio Senate Bill 285

On a typical day, more than 700 people are injured in distracted driving crashes, according to the National Safety Council. In a 2019 survey, AAA found that 74 percent of Ohioans strongly agree that the dangers of using a smartphone for texting, emailing, and social media can be as serious as drinking and driving. This is a constant worry for bicyclists and other vulnerable road users.

Today, distracted driving is a primary offense in Ohio only for drivers less than 18 years of age. SB 285 would make distracted driving a primary offense for all ages.

Do you support allowing officers to pull over and possibly cite anyone they see using a wireless communication device, as Ohio SB 285 would allow?

How would you work to make it happen?

**Phil Plummer\*** – I support allowing officers to pull over and cited for distracted driving. This is a serious problem and needs to be addressed.

**Cate Berger –** I am a proponent of this Senate Bill, and its efforts to curb distracted driving and further codify this statue across Ohio. I would vote to pass this measure in the House as an elected Representative and would work on the behalf of the constituents of the 41st to rally others to do so as well.

Andrea White – As elected Clerk of Court for Kettering Municipal Court for the past 16 and a half years, I see the impact of distracted and impaired driving on a regular basis. I also know that the legislation passed in 2018 that added the potential of an additional \$100 fine on a driving offense if distracted driving is cited does not appear to be even making a dent in this problem.

As a parent, grandparent, driver and cyclist, I am concerned about what I see on the roads when I am walking, biking and traveling in a car. I support making distracted driving a primary offense in Ohio. Officer input, buy-in and training will be key to ensuring that implementation is effective and consistent statewide. Citations need to be well documented and defensible so that disputed cases can be properly adjudicated in court.

More also needs to be done to teach and change behavior and cultural norms. I support recommendations from Governor DeWine's Distracted Driving Advisory Council, including increasing education on distracted driving in health classes, expanding content around distracted driving in Ohio's Driver Education curriculum and adding distracted driving laws in the "Digest of Ohio Motor Vehicle Laws." Effective promotion of driving without distraction through digital highway signs, educational materials, digital public service announcements and other ongoing education and norming strategies will be necessary to effect cultural change.

**Kim McCarthy -** We already have adequate laws against distracted driving (forbidding texting while driving [ORC 4511.204 as well as ORC 4511.991]). I'm

not a lawyer, but a reading of SB 285 seems to indicate that using my GPS while driving could also be considered an offense. How is that reasonable? I would suggest that rather than adding yet another law to the mix, we should direct our focus on better educating drivers—especially teens and new drivers—about the dangers of cellphone use, and on enforcing those existing laws that are available to address this problem.

So, devices mounted in the car being used for GPS or other uses would be exempt. I do believe smart devices in the car can lead to distracted driving and resulting in accidents. Distracted driving should be a primary offense for any age. I would advocate for

and support Ohio Senate Bill 285.

**Wade Westfall \* -** Yes, I support further advancing the safety of cyclists. I would support Ohio SB 258. I would work with the sheriff to implement the enforcement and further education of cyclists and drivers.

Transition Bill and HB 176, the Share the
Road both signed into law by the Governor.
I believe driver awareness of the laws
were accomplished with road signs and
social media spots.

Additionally, I suggest supplemental communication to drivers by asking:

- My State Representative and Senator to include an article in their communications with their constituents.
- My local government officials to include an article in their communications.
- Local service clubs to mention at their meetings and in their bulletin.
- My email contacts to share my article to others.

I will continue to work with the biking community to promote bike safety.

Grassroots/community level buy-in and promotion through special events, infusing awareness into existing community festivals, concerts, etc., and engaging cycle shops, business and community groups, schools and other entities as partners in promotion can help increase the use of active transportation.

# Question 2 (for county candidates): Complete Streets

Complete Streets policies are based on the belief that everyone – regardless of age, ability, income, race, or ethnicity – ought to have safe, comfortable, and convenient access to community destinations and public places, whether they are walking, driving, bicycling, or taking public transportation. The policies are necessary because too many of our streets are designed only for speeding cars or creeping traffic jams.

By adopting a Complete Streets policy, communities direct their transportation planners and engineers to routinely design the entire right of way to enable safe access for all users, regardless of age, ability, or mode of transportation.

for new street design accommodates all

Arlene Setzer – As the recent past mayor of Vandalia, I was instrumental in planning for a safe bicycle route with signage and designated bike lanes from the west boundary of the city to the east side. At the eastside point (Taylorsville Dam and bikeway from Tipp City) work is in progress to easily connect the bikeway trail. This point of access has the Vandalia Golf Course (Cassel Hills Golf Course) has use for parking, if necessary, and rest facilities with food available. As development occurs, other amenities are planned. I did support the engineering and planning and Vandalia is on our way to make it happen.

**Paul Gruner\* -** We essentially have that policy in the County Engineer's Office. Projects that we do that involve improving sections of road always involve federal funds, so we follow the MVRPC Complete Streets Policy. One example is our Third Street Bridge project, which will have a 10' walk on the north side and a 17' trail on the south side. In addition, we are re-connecting the trails under the bridge and providing a new connection in cooperation with the MCD. We are also providing bas reliefs on the walls on each side of both projects commemorating local history and peace. On small projects that don't involve federal funds, we always consider whether there are needs for connections that can be incorporated. Our rural county roads are not bike friendly but would require significant investments to widen that we just don't

have. Only experienced riders should use them. In most areas of the county, the offroad trails system (which I brag about topeople in other regions and states whenever I get the chance) provides preferable options. The Montgomery County Planning Commission has standards for roads in new developments. Their standards provide for sidewalks but could certainly be updated to reflect bike needs. We work for the MCPC in implementing their standards in new subdivisions, but do not have a seat on their commission. Your organization should probably work with individual planning commission members regarding this item. I will talk with Erik Collins to get his take on this.

## Question 3. Clean Ohio Funds

Clean Ohio Recreational Trails
Funds have created more than 600
miles of multi-purpose, recreation
trails in the state. With trail use
increasing by up to 200 percent, the
COVID-19 crisis has demonstrated
how important these trails are for
Ohioans' physical and mental
health. Trails also benefit nearby
businesses and provide needed
transportation options for those
without cars. Unfortunately,
continuing funding for the Clean
Ohio Recreational Trails program is
not assured.

Bike Miami Valley drafted one of the nation's first regional bikeway plans, which was adopted by Dayton's regional planning commission in 1973. This proved instrumental in the development of much of the recreational trail system that is celebrated today as The Nation's Largest Paved Trail Network.

Today, Bike Miami Valley is the founding organization of the Miami Valley Cycling Summit, an event held biennially around the region. The organization serves as the umbrella organization for five local chapters in Centerville, Kettering, Piqua, Springfield and Yellow Springs. Bike Miami Valley also co-manages the Link: Dayton Bike Share system in downtown Dayton with Greater Dayton RTA. The program keeps more than 3,500 users rolling annually.

Bike Miami Valley is recognized as a Platinum Level Bicycle Friendly Business<sup>SM</sup> by the League of American Bicyclists.



**Starting October 6th,** early voters can vote at their county board of elections weekdays between 8 a.m.-5 p.m. In the final two weeks leading up to Election Day, hours extend later during the week, and the boards open for limited hours on the weekends.

Check your county Board of Elections for details. Mail in ballots can also be dropped off at your county board of elections. Miami County is the only county in our region that does not early vote at the board of elections, see address details below.

The final day to vote early in person is Monday, Nov. 2 before 2p.m.

The deadline to request an absentee ballot this fall is Oct. 31 at 12 p.m.

The Secretary of State's Office recommends getting your absentee ballot in one of the following ways:

- Call your local board of elections and ask them to send you a form.
- Or, if you're one of 8 million
